Whereas, the General Administration Department vide O.M. No. GAD/MTG0RBIV/63/2021-09-GAD dated 19.10.2021 forwarded the selection list recommended by the Services Selection Board vide letter No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 to this department for issuing appointment orders in respect of 622 candidates in the Public Works (R&B) Department as per the standard terms and conditions already issued from time to time by the Government; and

Whereas, on the recommendations of the J&K Services Selection Board duly endorsed by the General Administration Department, the department issued formal appointment orders in favour of the candidates, whose verification reports got received from the Criminal Investigation Department duly endorsed by the concerned Deputy Commissioners; and

Whereas, the appointee(s) had been directed to report to the office of the Chief Engineer, PW(R&B) Department Jammu/Kashmir within a period of 21 days from the date of issuance of order and such candidates who fail to join within the stipulated time, shall forego their right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice; and

Whereas, vide Government Order No. 10-PW(R&B) of 2022 dated 11.01.2022, amongothers, Shri Muneeb-Ul-Majeed (Orderly) S/o Ab. Majeed Dar R/o Dadipora Kulgam under OM Category was appointed as Orderly in the Kashmir Division; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir vide his office communication No. CE/RBK/ADM/36477 dated 10.02.2022 reported that Shri Muneeb-Ul-Majeed (Orderly) S/o Ab. Majeed Dar R/o Dadipora Kulgam under OM Category has failed to join within the stipulated time period of 21 days, prescribed in his appointment order.

Now, therefore, it is ordered that the appointment of Muneeb-Ul-Majeed (Orderly) S/o Ab. Majeed Dar R/o Dadipora Kulgam under OM Category selected under the provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020 pursuant to Advertisement Notification No. 01 of 2020 dated 26.06.2020, failed to join within stipulated time period is hereby cancelled *ab-initio*.


