Subject: Appointment of Class-IV (MTS) in the Divisional/UT and District Cadres in the Public Works (R&B) Department-Cancellation thereof.

Whereas, the General Administration Department vide O.M. No. GAD/MTGORBIV /267/2022-09-GAD dated 27.10.2022 had forwarded the selection list of candidates recommended by the Services Selection Board vide letter No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 to this department for issuing appointment orders in respect of 843 candidates in the Public Works (R&B) Department as per the standard terms and conditions already issued from time to time by the Government; and

Whereas, on the recommendations of the J&K Services Selection Board, endorsed by the General Administration Department, the department has issued formal appointment orders in favour of the candidates whose positive verification reports were received from the Criminal Investigation Department duly endorsed by the concerned Deputy Commissioners; and

Whereas, the appointee(s) were directed to report to the office of the concerned Chief Engineer of respective Division allotted in the selection list with the condition in their appointment orders that they shall join within a period of 21 days from the date of issuance of orders, failing which, if any, shall forego his/her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice; and

Whereas, among others, one candidate namely Shri Divyam S/o vijay Kumar R/o Kathua (SL S.No. 1732, Roll NO. 191342176382) was also appointed as Class-IV (MTS) in the Public Works (R&B) Department vide Government Order No. 386-PW(R&B) of 2022 dated 29.10.2022 and his services were placed at the disposal of the Chief Engineer, R&B Kashmir; and

Whereas, the candidate submitted a representation via mail that due to bad health condition he was not able to join service within stipulated time period for the post for which he has not produced any evidence; and

Whereas, the matter was taken up with the Chief Engineer, Kashmir vide department's letter No. PWD-NGAZOCIV/13/2023-05 dated 12.01.2023 for furnishing a report, who in response vide communication No. CE/RBK/ADM/32532 dated 02.02.2023 has reported that the candidate namely Shri Divyam S/o Vijay Kumar (SL S.No. 1732, Roll No. 191342176382) under ALC/IB Category in the Divisional Cadre Kashmir has failed to join within the stipulated time period of 21 days, prescribed in his appointment order.

Now, therefore, in view of the report furnished in the matter by the Chief Engineer, Kashmir, it is hereby ordered that the appointment of Shri Divyam S/o Vijay Kumar R/o Kathua selected under the provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020 pursuant to Advertisement Notification No. 01 of 2020 dated 26.06.2020 vide Government Order No. 386-PW(R&B) of 202 dated 29.10.2022 in the Public Works (R&B) Department, who has failed to join within stipulated time period is hereby cancelled ab-initio.
