Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 and the General Administration Department's O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Mr. Rashpal Singh S/o Shiv Saran R/o Rathua, Rathua Ghou Manhasan, Jammu under OM/ESM Category, Application No.171801722 & Roll No.181257142200 Divisional Cadre Kashmir was among others, appointed to the post of Chowkidar vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021; and

Whereas, vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021, among others, the services of Mr. Rashpal Singh were placed at the disposal of the Chief Engineer, PW(R&B) Department, Kashmir for further posting; and

Whereas, while being posted in the office of the Chief Engineer, PW(R&B) Department, Kashmir Mr. Rashpal Singh joined Government service on 12.11.2021 and posted in R&B, RRCR vide office order No. K-115(ADM) of 2021 dated 17.11.2021 by the Chief Engineer; and

Whereas, subsequent to his appointment, the Chief Engineer, PW(R&B) Department, Kashmir vide letter No. CE/RBK/ADM-37866-67 dated 25.02.2022

reported that the official has tendered his resignation in the Public Works (R&B) Department before Executive Engineer, (R&B) Right River Circular Road Project Srinagar on 27.01.2022 on the grounds that he has been appointed in defense service Corps (DSC) as General Duty; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation w.e.f. 27.01.2022.

Now, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Rashpal Singh S/o Shiv Saran R/o Rathua, Rathua Ghou Manhasan, Jammu under OM/ESM Category is hereby accepted and he is discharged from the service w.e.f. 27.01.2022.
