Whereas, on the recommendation of the Services Selection Board, J&K conveyed vide No.JKSSB-PLAN/25/2022-03 dated 03.03.2023 & No. JKSSB-PLAN/25/2022-03 (E- 7069680) dated 07.07.2023, among others, Ms. Balvinder Kour D/o Jasbir Singh was appointed as Junior Assistant vide Government Order No. 457-PW(R&B) of 2023 dated 08.11.2023 and her services were placed at the disposal of Chief Engineer, PW(R&B) Department, Central Kashmir; and

Whereas, subsequent to her appointment, the appointee was directed to report to the Chief Engineer, PW(R&B) Department, Central Kashmir within a period of 21 days from the date of issuance of appointment order failing which the appointment shall be deemed to have been cancelled ab-initio without any notice; and

Whereas, Ms. Balvinder Kour D/o Jasbir Singh has failed to join/ report to the office of Chief Engineer, PW(R&B) Department, Central Kashmir within stipulated time period of 21 days as per report furnished by the Chief Engineer, PW(R&B) Department, Central Kashmir vide his communication No. CE/R&B/CK/ADM/8386 dated: 17/02/2024; and

Whereas, as per Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 under endorsement No. GAD(SER) Genl/Circ/06/01 dated 04.12.2019 issued by the General Administration Department, it has been notified that the candidates who fail to join within a period of 21 days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

Now, therefore, in view of the aforementioned report furnished by the Chief Engineer PW(R&B) Department, Central Kashmir in the matter, it is ordered that the appointment of Ms Balvinder Kour D/o Jasbir Singh as Junior Assistant under EWS category in the Public Works (R&B) Department pursuant to Government Order No 457-PW(R&B) of 2023 dated 08.11.2023 is hereby cancelled ab-initio having failed to join within the stipulated period.
