Subject:- Exemption from the routine exercise of transfer/rotational transfer.

The Ministry of Personal, Public Grievances & Pensions, Department of Personnel and Training, Government of India inter alia has issued following guidelines on exemption of employees from exercise of transfer/rotational transfer:-

“Considering that transfer of a Government employee who serves as the main care giver of persons with disability would have a bearing on the systematic rehabilitation of persons with disabilities, the Government of India vide their OM No. F. 42011/3/2014-Estt. (Res) dated June 6, 2014 issued instructions to exempt such employee from routine exercise for transfer/rotational transfer, subject to administrative constraints.”


Further the DOPT, Government of India vide their F. NO. 42011/3/2014-Estt. (Res) Dated 08.06.2014 has issued further instructions that with the enactment of the Rights of Persons with Disabilities Act, 2016 on April 17, 2017, the following instructions are issued in super-session of the above mentioned Office Memos of even number dated 06.06.2014, 17.11.2014, and 05.01.2016 with regard to the eligibility for seeking exemption from routine exercise of transfer/rotational transfer:-

(i) A Government employee who is a care-giver of dependent daughter/ son/ parents/ spouse/ brother/ sister with specified Disability, as certified by the certifying authority as a Person with Benchmark Disability as defined under Section 2(r) of the Rights of Persons with Disabilities Act, 2016 may be exempted from the routine exercise for transfer/ rotational transfer subject of the administrative constraints.

• The Specified disability has also been defined in detail under the above referred communication of DOPT, Government of India.

In view of the above, it is hereby impressed upon all the Engineers/ employees/Officials (falling under above category) working under the Administrative control of Public Works (R&B) Department to upload their authentic disability certificate (as specified in the schedule to the Rights of persons with disability act, 2016) duly attested by the concerned DDO along with their recent photographs and within a period of 15 days positively so as to claim exemption in this regard.

Any claim/exemption whatsoever, for rotational transfer shall not be entertained by the department in case the requisite details are not uploaded on JKPWOMAS portal.
