Subject: Fixation of seniority of Er. Mubarik Ahmad Mir, I/c Assistant Executive Engineer (Mechanical) Degree Holder as Assistant Executive Engineer (Mechanical) Degree Holder - Promotion/Regularization thereof .

Whereas, among others, the matter regarding promotion / regularization in respect of Er. Mubarik Ahmad Mir, I/c AEE(Mechanical) as AEE(Mechanical) was placed before the DPC/JKPSC.

Whereas, the Departmental Promotion Committee was held under the Chairmanship of Dr. Farooq Ahmad Lone, Hon'ble Chairman, J&K, Public Service Commission on 17.05.2022. In the meeting, 31 I/c AEE (Mechanical Degree Holders) were cleared by DPC. However, the DPC withheld recommendation for regularization of Er.Mubarak Ahmad Mir, I/c AEE(Mechanical) due to the following reasons:-

"to withhold the recommendations in respect of Mr. Mubarak Ahmad Mir, I/c Assistant Executive Engineers (Mechanical) who has been absorbed in Public Works(R&B) Department vide Government Order No.363-PW(R&B) of 2010 dated 03.12.2010 but his seniority has not been fixed so far in the seniority list issued vide Government order No.127-PW(R&B) of 2022 dated 08.04.2022 which has been operated in the instant proposal. However, after the department assigns him appropriate place in the said seniority list. Thereafter, the department shall submit the proposal regarding his regularization as Assistant Executive Engineers(Mechanical) along with all the requisite documents like Vigilance Clearance, APRs, Work and Conduct/Integrity Certificate. After scrutiny of the documents the recommendation shall be released in favour of Mr. Mubarak Ahmad Mir, I/c AEE, against roster point 01-OM w.e.f. 01.06.2005 with the approval of the Chairman DPC concerned".



Whereas, vide Government Order No.363-PW(R&B) of 2010 dated 03.12.2010, in relaxation of Rules, Er.Mubarik Ahmed Mir, Assistant Engineer (Mechanical) was absorbed in this department with effect from 27.03.1993 and his lien was terminated from the SIDCO and the seniority of the said Engineer was to figure at the bottom of the seniority list of Assistant Engineers (Mechanical) circulated on 03.01.1997. The ibid order was issued with reference to Cabinet Decision No.180/15/2010 dated 17.08.2010.

Whereas, a revised seniority list in respect of Assistant Engineers and Assistant Executive Engineers (Mechanical) was issued vide circular No.1 PW of 1997 dated 03.01.1997 by the Public Works Department.

Whereas, as per the Government order No.363-PW(R&B) of 2010 dated 03.12.2010, the seniority position of Er. Mubarik Ahmad Mir, shall fall below the name of Er. Ashok Kumar (Sty.No.373) in the seniority list issued vide circular No.1 PW of 1997 dated: 03.01.1997, and above Er. Mohan Lal Pandita in the seniority list issued vide Government Order No.127-PW(R&B) of 2022 dated 08.04.2022.

Whereas, the tentative Seniority Position is assigned to Er. Mubarik Ahmad Mir, I/c AEE (M) as 374.

Now, therefore, all the concerned members of the service (i.e, Assistant Executive Engineers Mechanical Degree Holders) are hereby informed through this notice for obtaining objections, if any, to this effect within a period of 05 days from the date of issuance/publication of this notice. Any Engineer, if aggrieved with the seniority position assigned to him may represent to the PW(R&B) Department through post/e-mail or manually within a period of 05 days from the date of issuance of this order. If no objection within a stipulated period is received from any Engineer, this notice shall be treated as final.
