Subject:- OA No. 762/2023 before the Hon'ble CAT titled "Tariq Mehmood Qureshi V/s UT of J&K and others" - Fixation of seniority thereof.

Notice

Whereas, the final seniority list of Junior Engineers (Civil) Degree holder of Public Works(R&B) Department was issued vide Government Order No. 460-PW(R&B) of 2019 dated: 22.10.2019; and

Whereas, Er. Tariq Mehmood Oureshi (OSC) appointed as diploma holder vide Govt Order No. 148-PW(R&B) of 2007 dated: 16.04.2007 and later after obtaining degree was treated as Degree holder (Civil) w.e.f 29.12.2009 vide Govt Order No. 316-PW(R&B) of 2013 dated: 13.09.2013; and

Whereas, while fixing the seniority of JE (Civil) degree holder he was inadvertently placed at Sr. No. 621, presuming his appointment as degree holder but the fact of the matter is that he was treated as JE (Civil) degree holder w.e.f 29.12.2009;

Whereas, Er. Tariq Mehmood Oureshi filed representation dated: 11.06.2023, in the Public Works Department and had requested to re-fix his seniority at Sr.822 and promote/place him as I/c AEE(Civil);

Whereas, he also filed OA No. 762/2023 before the Hon'ble CAT titled "Tariq Mehmood Qureshi V/s UT of J&K and others" wherein Hon'ble CAT in its order dated: 20.07.2023 in the instant case ordered as under:-

"The respondents are directed to consider his representation dated 11.6.2023 as per extant rules and to take appropriate action within a period of 06 (Six) weeks from the date of receipt of a copy of this order. The applicant will be entitled to consequential relief, if any, after his seniority is determined appropriately."

Whereas, in the light of the directions of Hon'ble CAT, the representation of the petitioner was examined in the department and found genuine and his name needs to be incorporated at Sr. No 821-A in the Govt. Order No. 460-PW(R&B) of 2019 dated: 22.10.2019;

Before incorporating his name at the appropriate place in the seniority list of Junior Engineer (Civil) Degree holder issued vide Govt. Order No. 460-PW(R&B) of 2019 dated: 22.10.2019, objections are invited, if any, from the members of the service for inclusion of his name in the seniority list, duly routed through HoD/Chief Engineer concerned by e-mail Compwd@redifmail.com) or CRU within a period of 10 days from the date of issuance of this notice.
