Subject: Regularization of Engineers (Mechanical) -Submission of APRs and other requisite documents.

Notice

The Department is in the process of submitting a proposal to the Jammu and Kashmir Public Service Commission to consider regularization of In-charge Executive Engineers (Mechanical). However, during examination, it has been found that many engineers have not submitted complete APRs of the relevant period, Work and Conduct/ Integrity Certificates, and posting details since entry into service for uploading on the Vigilance Clearance System (VCS) portal for seeking their vigilance status.


This Department has time and again informed all the engineers to upload their APRs and other requisite documents on the portal of this Department i.e JKPWDOMS and posting details on VCS portal through the concerned Chief Engineer/HoD however, still many of the engineers have failed to adhere to the instructions issued from time to time.

Therefore, the following In-charge Executive Engineers (retired/in-service) of Mechanical wing, who have not uploaded their APRs for the last 05 years and their Work & Conduct and Integrity Certificates on JKPWDOMS and posting details on VC portal through the concerned Chief Engineer/HoD, are once again advised to upload the same within ten (10) days positively for enabling this Department to consider their cases for promotion/regularization:-
