
Notice

The date of birth recorded in the tentative seniority list shall not be considered final or authentic but will be subject to verification from the service book and matriculation certificate of the concerned engineer.

In case no objection is received within the stipulated period, the tentative seniority list shall be treated as final. The tentative seniority list shall also be available on the official website of the Public Works (R&B) Department at www.jkpwdrb.nic.in.


