Subject: O.A No. 61/256/2025 titled Mohd Javaid V/s UT of J&K and others.


WHEREAS, you have filed the above mentioned O.A before the Hon'ble Central Administrative Tribunal and the Hon'ble Tribunal vide Order dated 11.03.2025 has passed directions, the operative part of which is given as under:-

Keeping in view the limited prayer made by the learned counsel for applicants for accord of consideration, this OA is disposed of with a direction to the respondent to treat this OA as representation of the applicants along with earlier representations pending before the competent authority and consider the case of the applicant in light of judgment passed by the Hon'ble Apex Court in Suraj Parakash Gupta & Ors Vs State of J&K & Ors, dated 28.04.2000, reported as AIR 2000 SUPREME COURT 2386 followed by the Government Order No. 107-GAD of 2022 dated 16.01.2002 read with Government order No 743-GAD of 2007 dated 28.06.2007. The respondents are further directed to pass a reasoned and speaking order after considering their claims and during the said process the applicants shall also be afforded opportunity of being heard.

The respondents are also directed to communicate the order so passed to the applicants. The whole exercise shall be undertaken within a period of six weeks from the date of receipt of a certified copy of this order.

The respondents are restrained from making further promotion to the higher post of Superintending Engineer either on substantive basis or on in-charge basis, till the claim of the applicants are not considered through their representations alongwith prayers made in this OA.

NOW, THEREFORE, through the medium of this notice, in pursuance of the direction of the Hon'ble Central Administrative Tribunal dated 11.03.2025 , you are advised to visit the office of the Administrative Secretary, Public Works (R&B) Department on 15.04.2025 (Tuesday) at 1.00 PM for a physical/virtual hearing in the instant case. You are also advised to submit representation (if any) by or before that scheduled time of hearing
