





CIRCULAR

It is enjoined upon all Head of Departments / Executing Agencies of Public Works (R&B) Department to strictly adhere with following instructions while issuing Road Cut Permissions to various Government and Private Organizations, and during restoration of roads thereof.

1. The application for road cut permission received from any Government institution or Private Agency must clearly indicate the purpose of road cut, scope of work, project execution plan and the time of completion.
2. The application must be duly forwarded to concerned R&B Division for preparation of estimates, on account of restoration of road, post road cut, keeping in view the scope of work.
3. The damaged road portion shall be restored to original specifications upto base course alongwith surface / wearing coat for the entire road width. The road restoration estimates must be framed accordingly, henceforth.
4. The road cut permission shall be issued by the competent authority, only after the realization of the deposit money as restoration charges, from the intending department / agency, after following due procedure.
5. The road cut shall be executed by the intending agencies strictly as per the permission, with due care to public and road safety, under the guidance of concerned R&B Division.
6. The concerned R&B Division shall ensure compliance of intending department in respect of accorded permission, scope and schedule of work including the time of completion.
7. The road cut permission shall be valid for specific road and period only. Any deviation in respect of road or period shall warrant action against the intending agency, under law, including confiscation of machinery and equipment.
8. However, extension in time may be granted by the competent authority on the formal request of intending department supported with reasons for delay.

The road cut permissions should be henceforth provided with, these conditions in addition to the rules already in vogue.
