Er. Satish Kumar, Incharge Executive Engineer of PWD (R&B), Division, Jammu East is retiring from government service after attaining the age of superannuation on 28-02-2025, as per the retirement notification issued by the PW(R&B) Department vide No.PWD/GAZZ/191/2022-05( CC 7329587) dated 17-01-2025. As per the available records of the PW(R&B) Department RDA/Departmental Proceedings are pending against the Officer and have not been finalized till date.

**Now therefore,** the recommendations of Chief Engineer, PW(R&B) Department, Zone Jammu, supporting documents and self undertaking duly countersigned by the DDO concerned submitted by the officer "**No Demand Certificate**" on account of Car/Scooter and House Building Advance beyond September, 1985 in favour of Er. Satish Kumar, Incharge Executive Engineer of PWD (R&B) Division Jammu East, is hereby issued, subject to the following conditions:
